Trustee Qualifications
Stanley H. Mathis Foundation

Minimum qualifications:

- Must be an RANM member in good standing at the time of application.
- Must demonstrate leadership knowledge and acumen at either the local or state level.
- Must commit to the applicable term of service and the attendance policy, indicate a willingness to remain a member of the Committee throughout the term of service, and agree to abide by the SHMF Bylaws and Policies as they may be amended from time to time.

Attendance Policy of SHMF

The members of the Board shall accept the responsibility for attendance at all regularly scheduled or specially called meetings as a condition of service.

Any Trustee who fails to attend two (2) consecutive meetings, whether regularly scheduled or specially called, in any calendar year during his/her term and without a reason for such absence submitted in writing and deemed acceptable by the officers of the Board, shall automatically be considered to have resigned.

Duties of the SHMF Trustees

- * The Trustees shall review and approve the annual dollar fundraising goals and shall create, coordinate and oversee the fundraising program.
- * The Trustees shall evaluate on an annual basis the effectiveness of the funds being raised and contributed.
- * The Trustees shall implement all rules, regulations, and activities of SHMF Policies.
- * The Trustees shall, on an annual basis, review and if necessary revise their current and long-term goals, objectives, and programs for consistency with the RANM strategic plan.
- * Each Trustee must assist with raising the necessary dollars to fund the operation of SHMF.
- * Each Trustee must assume a leadership role by setting a high personal standard of contributions to SHMF.
- * Each Trustee must attend all regularly called and special meetings of the Board.
- * Each Trustee is charged with supporting the actions of SHMF.
