

LEGISLATION UPDATE

UPDATE: SENATE BILL 99 & RENT CONTROL

On the afternoon of Tuesday, January 31, 2023, NMAR sent out a **Call for Action** regarding Senate Bill 99 & Rent Control.

The Bill, originally scheduled to be considered by the Senate Health and Public Affairs Committee on Friday, January 27, 2023, was rescheduled for Wednesday, February 1, 2023, at 1:30 PM due to the bill sponsors not being able to present. On Wednesday, a Democratic Caucus Meeting further delayed the committees meeting time by two hours.

Around 3:30 PM on Wednesday, the Chairman called the meeting to order, the first item on the Committee's Agenda was Senate Bill 99. After approximately two hours of testimony and debate, **the committee voted 6-2** (one committee member was out sick) **to table the bill**. The committee action meaning that no further action will occur, tabling effectively "kills" the legislation.

Thank you to everyone who responded to this Call for Action by contacting the members of the committee via phone/email, who showed up virtually, and who showed up in-person to oppose this legislation. Without your efforts this outcome would not have been possible.

What's next? Although SB 99 was tabled in committee, the issue of affordable housing and homelessness continues to be an important conversation in New Mexico. NMAR will continue to monitor legislation and act when necessary. NMAR opposes Rent Control, however, NMAR supports legislation that encourages the construction of rental dwellings and affordable housing across the state.
